The total number of sections of the school shall be restricted to 12 as per the number of sections reported during inspection, Number of the students shall be restricted to 32 in 8 sections (as per dimension reported during IC) . Further increase of sections, shall be subject to specific approval of the Board on the basis of the request of the

school as per affiliation bye laws subject to availability of class rooms of >500 ft dimension.

- * 2 The school has constructed a ramp to access the upper floors on part of staircase which is very steep and does not seem to be navigable by a wheelchair-bound student/staff, is not as per norms hence not acceptable. Therefore, the school is required to dismantle it and construct a proper ramp or install lift to access the upper floors as per norms of RPwD Act and guidelines of the Board within 3 months and submit compliance on SARAS portal.

- 3 The school has converted regular cubicles into CWSN toilets, but they are very small and narrow and there is no room for a wheelchair/walker to navigate. The school is required to construct the separate toilets for CWSN, boys and girls on every floor with proper permanent signage (on the cubicle) as per norms of RPwD Act and Board's guidelines, within 03 months and submit the compliance.

- 4 The composite lab has no work stations with proper utilities, seating and safety measures. The math lab is under equipped and there is no work space for students. The library is poorly stocked and does not have separate reading area for staff. The school shall upgrade its labs and library as per SoPs issued by the board within 3 months and submit compliance on SARAS.

- * 5 The school shall conduct training of its teachers with CoE Bhubaneswar within 03 months and submit the compliance

- 6 The school does not have well developed indoor and outdoor sports facilities. the school shall upgrade its sports facilities as per SoP issued by the Board within 3 months and submit compliance.

- 7 The school has not submitted building safety certificate issued by competent authority of government works Department. The school shall submit the building safety certificate in the prescribed format, including for the portion under construction, issued by the competent government authority within 3 months and submit compliance on SARAS portal.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be
The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye-Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
